- JEAN SLATER BURNS moved to use the Yacht Club and organize a caterer for the Installation dinner. SUSAN OPAVA seconded. Motion carried.
- SUSAN OPAVA moved the Board approve the use of Branch reserve funds to pay for the cost of the venue of the installation dinner at the Yacht Club on May, 20, 2019. SUSAN BRAZIL seconded. Motion carried.

The solid and consistent work of all Branch members has brought our endowment balance to \$109,286.22 as of January 31, 2019. Our local bank balance is \$7,406.43.

Spotlight on Branch member Susan Brazil

Being raised in the New Hampshire woods, Susan spoke French as her first language. Wandering in these woods with her dad encouraged her independence and a love of science and nature. She was encouraged by her parents to finish high school at age of 16 and was guided toward a four year nursing degree in education. Her first job was teaching in a Licensed Vocational Nursing Program in Massachusetts.



In 1962 Susan, with a girlfriend, came out to the West Coast for the Seattle

World's Fair and Susan decided this was where she belonged. After contacting the National Nursing Association, she was offered a job in Oakland pediatrics. When she arrived in student nursing housing dorms with her packed bags, her first acquaintance ended up as her sister in law, as Susan married her colleague's brother.

Susan spent nine years nursing, fifteen years teaching health programs for Adult Education and Regional Occupation Programs and served as a consultant for the California State Department of Education for eleven years. She earned her Master in Vocational Education at Cal State Sacramento and developed an occupational Health Program curriculum for 11th and 12 grade students.

Susan, her husband and three children moved to Lodi. After retirement Susan's parents from New Hampshire joined the family to help with the children. After a marriage separation Susan joined a singles' choir and her passion for music and travel flourished, with singing in Australia, Paris, Rome, NY Carnegie Hall, all over Europe. Her travel love developed more fully after trips to China, Thailand and Myanmar with friend who was a former Peace Corp volunteer.

Single parenting and learning to be alone added challenges, as she developed her philosophy of life. Her belief is that we are all one, part of the divine, individuals as part of the cosmos, focusing on compassion, forgiveness and love. Susan's reading includes spiritual as well as recreational subjects. Just recently she enhanced her love of music by joining a singing group called Kindred Spirits. Susan's curiosity and imagination is a gift that Susan shares with our AAUW branch members. She found our AAUW branch through the National AAUW website. Thank goodness!!!

PUBLIC POLICY

Imagine an America Without a Pay Gap

It is common knowledge that a woman in the United States makes 80 cents per dollar made by a man of similar qualifications. The pay gap is worse for women of color. In an era when women make up nearly 50% of the workforce, this pay gap burdens individual family finances and the economy. A recent study estimated the impact on society if the pay gap was corrected.



How would closing the pay gap be expected to impact families? 60% of working women and 66% single working mothers would see an increase in their pay Poverty rates for working women would drop by half from 8% to 3.8% Poverty rates for single working mothers would drop from 28.9% to 14.5%

How would the US economy benefit?

Closing the pay gap would increase gross domestic product an estimated \$500 million, roughly 2.6% of the GDP of our entire nation

The increase in women's earnings would be roughly 16 times what federal and state governments spent in 2015 for temporary assistance to needy families

The pay gap adversely impacts American families. Closing it would raise many out of poverty and reduce the need for public assistance. The question to ask our elected officials is not whether we as a society can afford to pay men and women the same income for the same work. The question is, how can we afford not to?

Five Cities Pismo Beach AAUW Scholarship Corporation Investment Policy

GOAL: It is the goal of the Scholarship Corporation (hereafter known as the "Corporation") to maintain an Endowment Fund (hereafter known as the "Fund") of sufficient amount the yield of which will support scholarships in the amount of \$1000 or more for three or more scholarships each year.

CORPORATION DIRECTORS: The Corporation consists of at least five Directors each of which is a member of Five Cities Pismo Beach Branch of AAUW.

- III. FUND INVESTMENTS:
 - A. The Directors of the Corporation will invest the Endowment funds with a goal of:
 - 1. Fixed income investments for protection against economic fluctuation (45%).
 - 2. Common stock funds for dividend earnings (45%).
 - 3. Cash (0-10%)
 - B. The Corporation anticipates the annual net yield of the "Fund" to finance the stated goal.
 - C. The "Fund" is tax exempt, therefore tax liability of the financial product need not be considered.
 - D. Corporation Directors will not over react to short term investment developments and will consider a complete market cycle and economic forecasts when allocating assets.
 - E. A Financial advisor, agreed upon by Corporation Directors, may assist in the allocation of assets based on Corporation goals

IV. RESTRICTIONS:

- A. EQUITY:
 - 1. No private placement, venture capital, or other securities not publicly traded.
 - 2. No ownership of options or future contracts without prior approval of Corporation Directors.
- B. FIXED INCOME:

Average quality of bond portfolio no less than S&P "BBB" rating (dollar weighted).

- V. ALLOTMENT OF SCHOLARSHIPS: The number and amount to be determined by the total annual income from the following:
 - A. The yield of the Endowment Fund at a withdrawal rate of 1-4% with a goal of maintaining an Endowment Balance of a minimum of \$100,000.
 - B. Individual donations to the Scholarship Corporation.
 - C. Income from Branch fundraising.
