

SCHOLARSHIP

The Scholarship Corporation, led by Kathi Pettersen, was tasked this year with choosing five highly-qualified, local high school senior girls from a pool of eligible young women, to each receive a \$1,500 scholarship.



She has a strong academic drive. At the age of 9, on a field trip to the Monterey Bay Aquarium, her mind became set that her future was to "have a role in the enormous ecosystem of the ocean." Her current plan is to enter Scripts in San Diego, to do research in the area of Marine Biology and earn a graduate degree that would help her achieve her goal of "saving the world!"

Kathryn says the Tech Trek Scholarship she received in 2016 from our Branch was a "revolutionary experience" for her, as it showed how women can take their place in STEM careers and make a difference. Two years later, she supported Tech Trek by becoming a counselor, giving back to the institution that had given her the confidence and drive she has today.

With a grade point of 4.515, she has followed her own unique path, devoting all 4 years in high school to the Robotics Team, as she believes underwater welding a useful tool in her future. As a senior, she is President of the Robotics Team as well as Head Welder, a surprising new "hobby" for her.

We expect the world will be a better place for her dedication to improving and protecting the ocean's ecosystems! **APRIL CROUCH**, a senior at AGHS, has been selected by the Scholarship Corp. as the 2021 recipient of a \$1500 Scholarship.

April is an outstanding student, with a GPA of 4.6 and a strong academic background of AP classes. Her AP test scores earned her an AP Scholar of Distinction award. She is currently enrolled in 5 more AP classes, in addition to the prestigious AP Capstone honors and research program. April is currently doing research on what motivates youth to vote. Her career goal is to earn a PhD in the field of Psychology, combined with Political Science, at the University of California Berkeley. With this degree, April intends to work for a non-profit to encourage young people to vote.

April was given the AP Civic Scholar Award for participation and success in the Dosomething.org & College Board joint program entitled "Civic Knowledge & Action Project." Her work, as President of the Young Progressives on campus, was to orchestrate voter registration drives that registered or preregistered hundreds of new young voters. She also organized them to initiate a schoolwide walkout related to gun violence.

As you can see, April has strong leadership abilities and was chosen to represent AGHS at Girls State last year, which she described as her most positive experience in high school. In the future, we want to encourage April in her goals of "combating real threats to our planet and democracy" as well as "fighting for the marginalized in our society."

Our choice for the AAUW Scholarship from New Tech High is **MARIE FOSTER**. Marie is an outstanding young woman in many ways, but her desire to major in Bioengineering and specifically engineering circular economies, a fairly new field, sets her apart!

Marie is ready to be an innovator and help change the direction of America's consumerism... to become a more sustainable economy! Her experiences with design and experimentation as a member of New Tech's Robotics Team, and being impacted by the different environment and lifestyle in Germany, where she spent her freshman year, energized and inspired her. Her achievement of getting a National Honor Society chapter started at New Tech, shows Marie's leadership, collaboration skills and ability to accomplish her goals!

Marie is a scholar! Her GPA was 4.6 and not only did she graduate early this past December, but she had also successfully completed 50 college credits!

She has been accepted into the Verto Education Honors Program (affiliated with UC San Diego) where she will spend her freshman year studying in several foreign countries. At the end of the year, she indicated an interest in going to UC San Diego.

Marie is a very forward-looking young woman. As she follows her dreams "to leave the world better, cleaner, and healthier"...there is no doubt that Marie will make an impact on our world!

As an administrator at Arroyo Grande High School states, Erika "is resilient beyond measure and her commitment to her education, despite every reason to fail, has been unwavering. She has endured more hardships than most in her 17 years and yet ... she's determined to go to college to rise above the cards she's been dealt."

Erika lost her mother to cancer when she was eight and her father was incarcerated for illegal drug use. From then on, she and her brother became part of the foster care system, and lived with multiple families. Eventually, she was placed with a family member, but still feels like a "guest" in their home.

Erika believes that education is the key to a better life for herself and this belief has carried her through the hard times.

In addition to maintaining a 4.06 and taking multiple advanced placement courses, she works 20 hours a week during the school year and full time in the summer.

She was accepted to multiple universities, but has chosen UCLA. She is interested in pursuing medicine and appreciates that the medical center is part of the university campus.

Although she knows the education and training to become a doctor is very difficult, she believes the hardships and chaos she has endured has prepared her for these challenges.

Erika dreams to make the world a better place and her teachers and advisors have no doubt she will do just that.

Our choice for the AAUW Scholarship from Nipomo High is **MEIA SCHRAM!**

Meia has quite a story! Meia was born in China, in an impoverished province and abandoned at a fire station! She was sent to an orphanage and at the age of two and a half, was adopted by an American family

An additional hardship for Meia...was that she was born with a cleft palate and because of this had to undergo many surgeries as a child and hours of Speech Therapy! These difficult experiences helped form Meia into a very resilient young woman...and also led her to discover what she wanted for her career:

to be a plastic surgeon - a children's maxillofacial surgeon!

Meia's GPA is 4.7, and she has been in the Top Ten of her class all 4 years of high school! She was accepted at many colleges and recently committed to UCLA. She is very excited because she loves LA! She will major in Pre-Med.



Everywhere you look you see Kathy Cohon in person or in print. This woman is a one-person show, supported by numerous AAUW Branch members.

Kathy is an East Coast child by birth, born in Johnstown Pennsylvania, near close family, truly raised by a village. School was comfortable, as she was a good student and the school principal lived across the street. She continued this close connection with her schooling, following in her father's footsteps.

Her aspirations for college were to attend the local Catholic College where two of her Dad's cousins were teachers. Kathy was the oldest of 5 children and the only girl. Her father died when she was 11 years old, and her mother went to work, keeping close eyes on her children with her school cafeteria job. And then, in 1960, Kathy's mother sold the house, packed up the 5 children and travelled cross country by train to relocate to her sister in Hawthorne California.

The plan was for the 5 children to attend college through the California's Community College system. And it happened, as 4 of the 5 children did attend college, and the 5th has a technical career.

SPOTLIGHT ON KATHY COHON

Kathy attended USC, supported by a 4-year scholarship, completing her teaching credential at UC Riverside. She was a classroom teacher and earned a Special Education Credential, which allowed her more job flexibility. Jobs were scarce and her move to Redondo Beach was facilitated by her Special Ed and Learning Disabilities Credential. She retired as a Special Ed/LED teacher.

In 1978, Kathy married Harvey, who was teaching in an adult training center. At that time, Kathy worked for Marilyn Corey in Hermosa Beach. When Kathy and Harvey were ready to start their family of two children, Superintendent Corey stated that Kathy was not allowed to resign. Imagine that!! Kathy then taught Mommy and Me classes for 7 years. In 1989 when Harvey's working hours were changed, the family decided it was time for a move. Kathy found a job in Santa Maria teaching Special Education/Learning Disabled classes. Next, she worked as a math aide for the Lucia Mar School District before retirement.

The Cohons' two children live in opposite parts of the country. Their son lives in New York and Kathy and Harvey make efforts to watch their two grandchildren grow, ages 7 and 4. Their daughter's family just moved from Memphis to Montana with their two children, ages 9 and 6. Kathy relishes in the grandparent privileges of hosting matching Christmas PJ parties and close personal connections with regular visits.

Kathy's hobbies include bike riding - an exceptionally avid participant; sewing and gardening, and following the weather. She believes that in a former life she was a weather person or semi-truck driver as she loves to drive. She acknowledges that she has a bit of attention deficit hyperactivity disorder and can be easily distracted. Biking allows her to go at her own speed, as does reading, another passion.

Fairness, social justice, "we versus me", is a theme of Kathy's life. She is missing the competitive gene, following cooperation as a model instead.

She has always been okay by herself, able to take care of her needs, while liking people.

A quick story sets the scene for Kathy's sense of fairness. In high school Kathy was planning her schedule with auto shop as an elective. Her rationale was that mother was a widow, she was the oldest in the family of five kids and she wanted to know about cars. The counselor said," No, you'll get dirty." Kathy's response was "Schedule me with PE next and I'll clean up." Then he said, "You'll get your clothes dirty." Kathy responded "I'll get a coverall to cover my clothes and then can change at PE." Finally, he looked at Kathy and said, "We don't have girls in auto shop."

She had watched her mother keep the family together and move from Pennsylvania to California, so the idea that she couldn't take shop because she was a girl was not fair. To this day Kathy has been influenced by the response that "she couldn't because she's a girl."

Kathy believes that she has had an easy life, coming from a blue-collar background to an educated teacher. Her mother seeped the family in culture. Kathy is spiritual but not religious, feels that her life has been blessed and believes in making lemonade out of lemons. Kathy's recent challenge has been helping her husband, Harvey, with his serious illness. Her memories of her sandcastle wedding on Redondo Beach display the creative fantasy of their relationship.

Kathy joined AAUW in 1981 where she found women with children and common goals and support for each other. Kathy has served in numerous officer roles for AAUW, organizing Herstory presentations, introducing the Cooking Together Group, fund raising bingo and bunco games and more. She is politically active and on spot for social justice. She does see herself as a "general" when running meetings or teaching adults. It gets things done, and nicely.

PUBLIC POLICY: LOBBY DAY ZOOM AT THE STATE CAPITOL, SACRAMENTO

On March 24 members of AAUW across California had the opportunity to be in direct contact with members of the California State Legislature. Our Public Policy Chair, **Jean Burns Slater** led a team of three AAUW California members to prepare and contact State Senator Scott Wilk from Santa Clarita, to explain and encourage passage of the legislative bills described below.

After the Lobby Day opening session, 30 teams of 3 or 4 AAUW CA members connected with individual legislators or their staff. Every effort was made for members to meet with their Assembly Member or Senator, with some teams having as many as 3 meetings during the day. In these meetings, members communicated information about AAUW CA, their branches and also the three bills which are high priority for AAUW in the current session.

- AB 92 Assembly Member Reyes Child Care Family Fees

SB 62 Senator Durazo
 AB 373 Assembly Member Min
 Garment Worker Protection Act
 Consumer Debt: Economic Abuse

The results of these meetings are important in several ways. Sixty legislators or their staff now know about AAUW and our commitment to improve the lives of women and girls in California. They'll remember us when we contact them again as our bills move through the legislative process. Follow up on these three bills progress will be provided through our Public Policy articles in our newsletter.

Garment Worker Protection Act Senate Bill 62

SB 62 would expand and strengthen enforcement of wage theft liability in the garment manufacturing industry, ensuring that retailers cannot use layers of contracting to avoid responsibility under the law. By eliminating the piece rate in the garment industry while still allowing for bonus and incentive payments, this bill would ensure that workers are paid for all time spent working

Consumer Debt: Economic Abuse Senate Bill 373

Survivors of domestic violence or elder abuse, and foster youth are often the victim of coerced or fraudulent debt, with debts taken out in their name without their knowledge or consent. These debts damage individuals' credit and force them into years of debt repayment, reducing their economic stability and leaving them vulnerable to future abuse, poverty, and housing instability or homelessness.

Child Care Family Fees Assembly Bill 92

This bill will create an equitable sliding scale for family fees that will alleviate the burden on working families struggling to pay for child care and early childhood education services. By increasing the affordability of child care to working families, this bill will benefit the economic recovery of the state by helping parents remain in the workforce and achieve economic stability.

State and federally funded programs help families, but they must still pay fees. This can make subsidized care unaffordable and jeopardize employment or education. The current fee structure penalizes families, since the fees increase as income rises, forcing families to have to make choices between paying childcare family fees or other basic needs.

CENTRAL COAST VOICES: CLOSING THE GAP ON EQUAL PAY

Each year, National Equal Pay Day reflects how far into the current year women must work to match what men earned in the previous year. Due to a gender gap in pay, it takes women an extra three months of wages to make up the difference. On average, women working full time and year-round are paid 82 cents for every dollar paid to a man who works full time and year-round. The wage gap is even greater for most women of color.

Host Kris Kington-Barker spoke with guests from San Luis County branches of the American Association of University of Women (AAUW) Linda Baker, President, AAUW Atascadero; Lynn Janeway, President, AAUW San Luis Obispo; and Dr. Susan Opava, AAUW Five Cities-Pismo Beach; about the work they do fighting to remove the barriers and biases that stand in the way of gender equity and to create a more economically secure world for women and girls, as well as what we can do as a community to close the gender pay gap.

NATIONAL AAUW OPEN MEMBERSHIP VIEWS

INFORMATION REGARDING THE NATIONAL AAUW BY-LAWS CHANGE PROPOSAL

"The AAUW National Board of Directors strongly supports elimination of the degree requirement for membership and will put the requirement up for a membership vote this spring. This important change is a critical step in bringing AAUW's bylaws and membership requirement in line with our mission of advancing equity for women and girls. While AAUW is fiercely committed to the educational attainment of all women, given our commitment to inclusion, this is simply the right thing to do.

This spring, AAUW members will <u>vote on a Long-standing membership requirement</u>, which creates a barrier to women who do not hold a college degree. By eliminating this requirement, AAUW can become a more diverse and inclusive organization, better aligned with the needs of women today."

The reasons given by National as to why we should drop the education requirement are:

- Because it is the right thing to do
- Because it is in keeping with our mission to advance gender equity
- Eliminating the degree requirement will bring AAUW membership criteria in line with its mission to advance gender equity.
- Greater diversity can only strengthen AAUW and our ability to advance equity.
- Times have changed and society has changed. AAUW strives to meet our mission and society's needs today.
- AAUW empowers women. How does keeping the membership requirement help you empower women?
- Just like our founding mothers, we can be role models for positive change in the world. But we cannot have the impact we seek when our membership criteria don't match our mission and values.
- AAUW is unique due to our breadth of programming, research, policy and advocacy, fellowships & grants, and most importantly, a grassroots membership that can be mobilized to fight for what we believe in. We should open this powerful grassroots network up to all who want to join the fight.
- Education comes in many forms. Those who do not have degrees can still be strong advocates for our mission.
- AAUW must evolve to survive.

"Proposals to eliminate the degree requirement for membership have come before the membership for vote a number of times. The Board feels very strongly that while the degree requirement made perfect sense at AAUW's inception, this requirement is now counter to our mission, and limits our ability to build the capacity needed to increase our impact as an organization.
