This in-person February 17th branch meeting, to be held at 11 am at SLO County Library Community Room, will feature a presentation about the book with **Dr. Maya Hislop**, Assistant Professor of English at Cal Poly, and author of the forthcoming book, *Bodies in the Middle: Black Women, Sexual Violence, and Justice*.

A Book Read to Commemorate Black History Month in February

"Reader, it is not to awaken sympathy for myself that I am telling you truthfully what I suffered in slavery. I do it to kindle a flame of compassion in your hearts for my sisters who are still in bondage, suffering as I once suffered." — Harriet Jacobs, *Incidents in the Life of a Slave Girl, Written by Herself*

Incidents in the Life of a Slave Girl is the first narrative written by an enslaved woman. It tells the story of Linda Brent (pseudonym for Harriet Jacobs). It is written as a letter to White Northern women to urge them to take up the cause of the abolition of slavery.



Tech Trek

At the January 2, 2024 Branch Board meeting I presented the information that I had regarding the cancelling of the Tech Trek camps at UCSB for the summer of 2024. After a thorough discussion about the possible hardship on any campers we would send this year due to the possibility of families needing to make two round trips to either UC Fresno, UC Santa Cruz, or Whittier College, the board voted to suspend sending any campers this year.

There has still been no specific information made available from the State Tech Trek team as to why the camps were placed on hiatus. An appeal by numerous Branch Tech Trek Coordinators for a more thorough understanding of the situation has not produced any clear information. A recent letter did say that 35% of the branches impacted by this camp closure have opted out of sending campers this year.

I have contacted the families of the three girls that had been nominated by their teachers and explained about the closure of the camps. I also informed their teachers and the rest of the teachers that had not yet nominated candidates.

I have decided to continue as Tech Trek Branch Coordinator for one more year (2025) in hopes that we will be able to resume camps at UCSB. I would very much like to have a Co-Coordinator working alongside me next year with a goal of taking over for 2026.

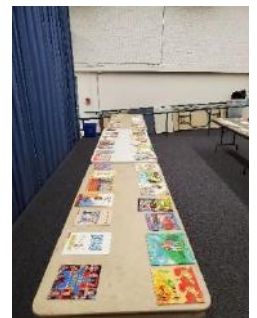

School Board Project

Kathi was our key note speaker at our October 2023 General Meeting at the Atascadero Library**

We, members of the AAUW California Public Policy School Board Project sub-committee, frequently come across materials from groups advocating for book-banning, curriculum censorship, and policies which negatively impact the lives of LGBTQ+ students, in the name of “Parent’s Rights.” For example, the House of Representatives recently passed H.R. 5, the “Parents Bill of Rights Act.” Eight governors have signed legislation with similar titles. H.R. 5 establishes the rights of parents to, among other things: review curriculum; inspect the books and other reading materials in the school library; be advised of policies that permit transgender girls to compete on female athletic teams or use bathrooms or lockers designated for females; and provide consent before a school may use their child’s chosen name or pronouns on forms, or change the child’s sex-based accommodations. Many of the state laws noted above require the removal of “inappropriate” materials upon the objection of a single person.

AAUW California recognizes that not all our members will find these policies objectionable. And to be sure, most of our members would agree with this statement from PEN America, a human rights and free expression organization: “There is no question that parents deserve a say in shaping their children’s educations; that they have a moral and legal responsibility for their children, and the freedom to make fundamental decisions for their families.” (Suzanne Nossel, PEN America CEO, Time Sept. 20, 2022.)

However, legitimate questions are raised when one parent’s “right” to control what their child reads and learns collides with another parent’s right to ensure their child has access to a broad and diverse range of educational materials. Or when a parent’s “right” to know if their child confides to a teacher regarding a sexual identity unknown to the parent collides with the student’s right to privacy. Or when one parent’s “right” to ensure her daughter doesn’t play on the same team as a transgender girl collides with that girl’s right to partake in all the same activities as other girls, or to feel safe in the campus environment. AAUW California advocates for a diverse curriculum in our schools, as well as the protection of all forms of gender identity and expression.

It is a cause of concern when the rallying cry of “parents’ rights” is, as stated by PEN America, “wielded to do far more than give parents their rightful voice; it is turning public schools into political battle grounds, fracturing communities, and diverting time and energy away from teaching and learning.” Additionally, according to the National Education Association (NEA), H.R. 5 “ignores the breadth of parental engagement” that already exists, “disregards educator experience and expertise” and “inserts the government into local decisions.”

PEN America worries that the current emphasis on working with schools for the betterment of the child has been replaced with a parental focus on wanting to impose their personal beliefs – moral, religious, and/or political – on the entire education system. As an organization founded on the principal of expanding educational opportunities, we might all heed Suzanne Nossel’s final words in her Time article: “The phrase ‘parents’ rights’ may have a nice ring to it, but the agenda now afoot in its name should sound alarms for all those who care about the future of public education.” Read more at: [Pen.org](https://www.pen.org),

The AAUW California Public Policy Program establishes policy directives that will guide our members, inform our legislative priorities, serve our mission to advance equity for women and girls through advocacy, and are consistent with our values of achieving fair and equitable opportunities for our diverse society. Toward that end, AAUW California advocates policies that promote, enhance and ensure:

Economic Security for All Women, including:

- Equity in the workplace
- Enforcement of workplace anti-discrimination statutes
- Security in retirement
- Access to job training for career development
- Work-life balance, including access to quality affordable childcare and paid sick and caregiving leave

Social and Racial Justice for All Members of Society, including:


- Self-determination in reproductive health
- Equal access to quality affordable health care, housing and a healthy environment
- Freedom from violence in all its forms and wherever it occurs, including violence against historically marginalized groups, and support for policies that reduce or prevent gun violence.
- Guarantee of civil and constitutional rights for all, including all forms of gender identity and expression, and all family structures
- Protection and expansion of voting rights
- Support for United Nations sustainable development goals which address human rights and women's and girls' concerns

Equal Access to Quality Public Education for All Students, including:

- Vigorous enforcement of Title IX
- Adequate and equitable funding at all educational levels, including pre-school and post-secondary
- Removal of barriers for girls to access instruction in STEM fields
- Civics instruction in all CA high schools
- Access to diverse staff and curriculum that represents historically accurate information
- Funding adequate to support a strong infrastructure, and equitable access to resources, including technology
- Opposition to the use of public funds for nonpublic and charter schools that do not meet public school civil rights and accountability standards

Increased Representation of Women in Leadership Roles, including:

- Proportional appointment to publicly held corporate boards
- Access to leadership skills training
- Access to programs that promote participation in public service careers
