#### **HELP MONITOR OUR LOCAL SCHOOL BOARD!**

Lucia Mar USD Board of Trustees Calendar 7:00 p.m. 602 Orchard Street, Arroyo Grande Next Meeting <u>December 16</u>

At the November 18, 2025 Board of Trustees Meeting, the LMUSD Board voted to follow the recommendations of the District Advisory Committee and opted to retain two books in the library at Arroyo Grande High School, which were seen as controversial by a group of parents. The Lucia Mar School District reviews instructional materials, including books, through a multi-step process involving teachers, administrators, parents, and community members. This process typically includes seeking stakeholder input, forming an advisory committee, evaluating materials against curriculum guidelines, and presenting recommendations to the Board of Trustees, which ultimately makes the final decision. The Board vote was 4 to 3 to retain the books, following the recommendation of the special advisory committee that heard the formal complaints. The meeting was well attended with three of our Branch members present and was extensively covered by KSBY News, The Telegram Tribune, and New Times.

The close vote to ban these books brings to our attention the upcoming process of 2026 School Board elections. During the 2022 election a slate of candidates, campaigned on a slogan to "rebuild" Lucia Mar Unified Schools. One candidate on this slate was successful at the 2024 election. Another "rebuild" slate is anticipated for the next election, to be held in November 2026.

Current Board President Colleen Martin has spoken with our Branch at two recent meetings, expressing the need to focus the District toward its mission: "Engage, challenge, and inspire students to be lifelong learners" and achieve their full potential. The District's vision is to become the "model school district for 21st Century Learning in the nation" by ensuring all students are prepared for the future through a rigorous, supportive, and inclusive educational experience. Balanced school board candidates, *without* a set of ideological views that encompass specific political, cultural, or religious beliefs, will best serve our community and students

In 2026 there are 4 seats up for election, offering a possibility of changing the entire school board focus. The trustees are elected based on their area of representation. Trustees' area of representation that are up for election are described below.

Four Trustee positions up for election in 2026 in the following areas

Area 3 Currently held by Andrea Naemi-Vergne

Area 5 Currently held by Colleen Martin

Area 6 Currently held by Eilene Pham

Area 7 Currently held by Donna Kandel

Details for the procedure for filing as a candidate are listed below. If you know someone who will serve our community and all students, please encourage them to file as a candidate. The filing period for the November 2026 election typically opens the second Monday of July and closes on Friday in August, 30 days after the initial filing date.

#### Job description

Local school board members are responsible for overseeing school operations within the district, typically including employment decisions regarding a district superintendent.

#### Eligibility requirements

You may be elected or appointed to a governing board of a school district if you are 18 years of age or older; a citizen of the state; a resident of the school district; a registered voter; and not disqualified by the constitution or laws of the state from holding a civil office. An employee of a school district may not be sworn into office as an elected or appointed member of that school district's governing board unless and until he or she resigns as an employee. If the employee does not resign, the employment automatically terminates upon being sworn into office. Any registered voter is eligible to be a member of the county board of education except the county superintendent of schools, any member of his or her staff, or any employee of a school district in that county.

Paperwork instructions: Submit paperwork to the county registrar of voters' office.

Filing requirements: No filing fee or petition signature requirement.

# AAUW: Gutting the Department of Education Betrays Students' Civil Rights

November 20, 2025

**WASHINGTON, D.C.** — The American Association of University Women (AAUW) is deeply alarmed by the Trump administration's escalating efforts to dismantle the U.S. Department of Education. These efforts include mass staff cuts and the recent announcement of six "partnerships" that shift the day-to-day work of major K–12 and higher education programs to other federal agencies.

These moves raise serious questions about how the Department can carry out the statutory responsibilities Congress assigned it in 1979. These were enforcing civil-rights laws in education, administering federal aid fairly and effectively, and ensuring equal educational opportunity for all students.

## Statement of Gloria L. Blackwell, Chief Executive Officer, American Association of University Women (AAUW):

"Let's be clear about what is at stake. The Department of Education was created to center students' rights and educational equity, not to outsource its core expertise across agencies whose primary missions are labor, health, interior affairs, or foreign policy. You cannot meet that mandate when the people and programs with the most expertise in K–12 equity, higher education access, Native education, international education, and childcare for student parents, are scattered across agencies whose missions are labor, health, public lands, and foreign policy. When you hollow out the Department and scatter its knowledge of K-12 and higher education, you make it harder for students to challenge discrimination and harder for Congress or the public to hold parties accountable. "

AAUW urges Congress to intervene and ensure that the Department of Education can do what the law requires it to do — protect students' civil rights and advance gender and racial equity in every classroom and on every campus.

Scam emails were sent that some members may have thought came from AAUW (but did not), and caused concern. Scam email senders are getting cleverer, but a few quick checks can help identify suspicious emails. Read on for more information and tips on spotting scam versus legitimate emails, and steps to take if you have spotted a scam message.

#### Step 1: Check who it is really from

- You may need to tap, click, or hover over the "From" name to see the full address.
- Make sure the domain (the part after the "@") matches the actual organization.
  - Example: <u>siteadmin@aauw-ca.org</u> is legitimate; <u>siteadmin@aauw-support.com</u> or <u>aauw-members@yahoo.com</u> is not.
  - Watch for sneaky look-alikes: <u>amazOn.com</u> (zero instead of "o"), <u>aauw-help.org</u> instead of <u>aauw.org</u> or <u>aauw-ca.org</u>.

#### Step 2: Scan for common red flags

- Urgent messages: "You must read this attachment/click this link right away!"
- Unexpected offers or prizes: "Click here to redeem."
- Requests for personal info or money, especially gift cards or wire transfers.
- Links and attachments you were not expecting. Hover your mouse over links (or press and hold on mobile) to preview the real web address. *If you are unsure whether the message is legitimate,* do not click if it looks unfamiliar or is shortened (like bit.ly).
- Spelling or grammatical mistakes or unusual wording. This is not always present, but it is a clue if spotted.

#### Step 3: What to do if the message appears to be a scam

- Do not respond to the email.
- Do not click links or open attachments.
- Report it as spam/phishing in your email program.
- Delete it.

#### If you are not sure whether the message is a scam or not

 Contact the purported originating agency through established channels to determine whether it is legitimate. Use an email, website, or phone number you have used before or know to be correct.

#### A quick summary of the high points:

- Look past the sender's display name: verify the full email address and domain.
- Be wary of urgency, prizes, and requests for personal info.
- Do not click on links or open attachments unless you are comfortable that the message is legitimate.
- Delete suspicious messages.

I hope this information is helpful. It's a rough world out there, but with a bit of knowledge and good habits, you can keep yourself safe.
